The start of an exciting New Year for Chatterley Whitfield Friends - Well I thought it would be an easy transition......THINK AGAIN......IT GETS BETTER......

You all know about Building 29B.... The documentation is presently with the legal department of the City Council, who we have been told have a backlog.....

We were informed that with effect 1.2.2018 the CCTV would become operative and there would be a 14 day hand over period when eventually there would be no onsite security..... WRONG.... Arrived on Thursday morning to be refused access to site as the security would go that morning. All the 'BIG Wigs' from the council were coming on site to collect the keys etc. Well quick phone call to Anthony Williamson and we were allowed on and we managed to get some work done in Deployment centre. Before we left the site we had an informal chat with the officers from the council.

Very interesting..... They are very aware of the 'Friends' and the work we do, but I for one was very frustrated in their general attitude brought about by the apparent lack of communication. It only took an email or phone to let us know what was happening....... Quite a few of the members did express their concerns about the situation....

So as from 1.2.2018 all access to the site must be authorised and a Permit to Access issued. I am still not sure who brings the keys and then does the key holder be it Council staff or Red Guard Security have to remain on site while we do !!!!!!!

The Digitization Grant:

Chatterley Whitfield Colliery closed in 1975 and a few years later in 1979 became a mining museum. It was one of the first museums to offer underground tours but in 1993 the Museum was closed. In 1994 the National Coal Collection was transferred to Caphouse Colliery, Wakefield and a lot of the historical artefacts were auctioned off. The site was abandoned and taken over by Stoke on Trent City Council. The Friends of Chatterley Whitfield were formed and have been active in Preserving the Past for the Future. 'The Friends' have rescued old maps, books, documents and artefacts left on site over the years and built up a substantial collection.

Our aim is to preserve the historical material by digitizing it before it is stored in a more appropriate but restrictive environment.

In the process of digitization the 'Friends' would like to share their experiences and encourage people from the local community to participate.

If the funding is successful it would be used for purchasing computers, suitable scanning equipment and artefact restoration materials.

The digitised collection(s) will be placed online and made more readily available.
